Are Hyundai Motor Group & LG Energy Solution making EV batteries?

SEOUL, May 26, 2023 - Hyundai Motor Group and LG Energy Solution (LGES) announced an EV battery cell manufacturing joint venture in the U.S. today. Hyundai Motor Group and LGES signed a memorandum of understanding to produce EV batteries in the U.S. and further accelerate the Group's electrification efforts in North America.

What is lges & Hyundai Motor Group's EV battery partnership?

LGES and Hyundai Motor Group aim to further strengthen the ties going forward with the EV battery cooperation. LG Energy Solution (KRX: 373220), a split-off from LG Chem, is a leading global manufacturer of lithium-ion batteries for electric vehicles, mobility, IT, and energy storage systems.

Will lges produce EV batteries in North America?

LGES and Hyundai Motor Group signed a memorandum of understanding to produce EV batteries in the U.S. and further accelerate the Group's electrification efforts in North America.

Where are lges batteries made?

Since then, the two have poured billions into three factories: The Lansing facility that LGES is acquiring; a Spring Hill, Tennessee, facility that started production in 2024; and a Lordstown, Ohio, factory that has been producing battery cells since 2022.

How many battery plants does lges have?

With this JV, LGES now has seven battery plants currently operating or being constructed in the U.S., where the company is concentrating most of its resources to expand the production capacity.

Will GM and lges jointly develop prismatic battery cells?

GM also announced Monday that it would work with LGES to jointly develop prismatic battery cells. Levy declined to share whether those cells would be produced at one of the remaining joint venture sites, or if they'll be manufactured in a yet-to-be-announced facility.
