

Does the photovoltaic bracket base have a certificate of conformity

How do I know if a photovoltaic module is UL certified?

Look for the UL Certification Mark on the product. Standards: Evaluated to the requirements of Standard for Photovoltaic (PV) Module Safety Qualification - Part 1: Requirements for Construction, UL 61730-1 and the Standard for Photovoltaic (PV) Module Safety Qualification - Part 2: Requirements for Testing, UL 61730-2.

Are PV modules compliant with building regulations?

5.5.4 Where mounting systems are certified or listed using a named PV module or modules then only those modules shall be used. The system is compliant with current Building Regulations for weather-tightness, fire and wind resistance.

What is a certificate of conformity?

This Certificate of Conformity is issued on a voluntary basis for the listed above. With reference to the Low Voltage Directive 2006/95/EC relating to the electrical equipment designed for use within certain voltage limits. It confirms that the listed equipment complies with the principal protection requirements of the directive.

What if a MCS contractor does not design a solar PV system?

3.1.2 Where MCS contractors do not engage in the design or supply of solar PV systems but work solely as a MCS Contractor for a client who has already commissioned a system design; then the MCS Contractor shall be competent to review and verify that the design would meet the design requirements set out in this Standard and this should be recorded.

Who should check the roof structure of a solar PV system?

5.9.4 The MCS Contractor shall ensure that the roof structure is checked by a suitably competent person to ensure it can withstand the loads imposed by the solar PV system. 5.9.5 For the typical roof structure types shown in Table 1, the calculation methodologies given should be used. A qualified structural engineer shall be consulted.

Does BS7671 require protection against transient overvoltage?

BS7671:2018+A2:2022 (regulation 443.4.1) stipulates the circumstances when protection against transient overvoltage must be provided. Even when those circumstances do not apply protection must still be provided unless the owner of the installation is prepared to tolerate the risk.
