Are export tariffs a good idea for solar PV?

What electricity export tariffs are required?

It requires licensed electricity suppliers to offer export tariffs to anaerobic digestion (AD), hydro, onshore wind, and solar photovoltaic (PV) generators with a total installed capacity up to 5MW, and micro-combined heat and power (micro-CHP) up to 50kW. The obligation came into force on 1 January 2020.

How do I export electricity to SEG?

Your property must have a valid Energy Performance Certificate (EPC) rating of D or above. Once these conditions are met, you can apply for a special export tariff with an SEG licensee, who will then pay you for any excess electricity you generate and export back to the grid.

Do you need a storage battery to export electricity?

With that being said, some of the most lucrative export tariffs on offer today aren't actually connected to the SEG, and they often don't require you to generate your electricity with a renewable source. In reality, all you need in order to achieve flexible import and export is a storage battery.

What happens if I export electricity from another SEG licensee?

You will then be responsible for seeking a new SEG tariff for your exported electricity from another SEG licensee. Any electricity exported between the point the contract from the previous SEG licensee stops and a new SEG contract is agreed with a new SEG licensee will not be the responsibility of the new SEG licensee.

What is the average solar export tariff?

Our analysis of the Ofgem SEG reports from 2020 to 2023 shows that the average solar export tariff has increased since the SEG launched. It started at an average of 3.15p/kWh in 2020, jumping to 4.52p in 2021, and then up to 6.78p in 2022.
