What are the French Southern and Antarctic Lands (TAAF)?

The French Southern and Antarctic Lands (TAAF) are at the heart of these ambitions. Made up of five districts - the Crozet archipelago, the Kerguelen Islands, Saint-Paul and Amsterdam, the Éparses Islands and Adélie Land - these territories are nevertheless one of the ultra-marine collectivities that are least well known to the general public.

## What is the French Southern Territories?

The territory is sometimes referred to as the French Southern Lands (French: Terres australes françaises) or the French Southern Territories,usually to emphasize non-recognition of French sovereignty over Adélie Land as part of the Antarctic Treaty System. The entire territory has no known permanently settled inhabitants.

Does France have territorial sovereignty over the Éparses Islands?

Although France's claim to the three austral lands (Kerguelen,Saint-Paul and Amsterdam and Crozet) is no longer contested, it is facing two major challenges to its claimto territorial sovereignty over the É parses islands.

What is a 'territory' in French energy policy?

The notion of 'territory' has only very recently attracted interest in the French energy policy arena, as attested by the 2014 National Debate about the energy transition and the July 2014 draft law on it.1 'Territory', 'local' or 'collectivity' here signify a realm that has a variable perimeter.
