What is MGM Green Energy Limited?

Who has power in Kyrgyzstan?

Executive power in Kyrgyzstan lies with the government, its subordinate ministries, state committees, administrative agencies and local administrations. In the energy sector, the government: Grants and transfers property rights, and rights for use of water, minerals and other energy resources.

What is MGM green energy limited's authorized share capital & paid up capital?

MGM Green Energy Limited's authorized share capital is Rs. 10,000,000 and its paid up capital is Rs. 4,108,600. The company is involved in the production, collection, and distribution of electricity. MGM Green Energy Limited's Annual General Meeting (AGM) was last held on N/A and its balance sheet was last filed on 31 March 2021.

How much does Kyrgyz energy project cost?

The project has a multi-phase programmatic approach with a financing envelope of \$125.7 million over 10 years. The first phase of the project will focus on supporting the Kyrgyz Republic to increase hydropower generation and enable renewable energy integration by strengthening the country's transmission systems.

Is Kyrgyz Republic a green economy?

The State Agency on Environmental Protection and Forestry has developed a first draft of "green economy" document - Concept for Long-term Development of the Kyrgyz Republic with Low Greenhouse Gas Emission until 2050. The National Statistical Committee is responsible for collecting official energy statistics.

What is National Energy Holding Company (NEC) in Kyrgyzstan?

In January 2016 the Kyrgyz Government established Open Joint Stock Company "National Energy Holding Company" to manage state-owned shares in the power sector companies. Executive power in Kyrgyzstan lies with the government, its subordinate ministries, state committees, administrative agencies and local administrations.

The energy sector represents 4% of GDP and 16% of industrial production, and hydropower accounts for two-thirds of energy production. Kyrgyzstan exploits coal and some oil and gas, but most hydrocarbons are imported.

Founded in November 2022 by the Cabinet of Ministries of the Kyrgyz Republic, the Green Energy Fund's mission is to develop an effective public administration system in the green energy sector.
