The United States Minor Outlying Islands consist of 11, mostly uninhabited islands in the Pacific (8 islands) and the Caribbean (3 islands) that are considered insular areas of the United States.

When was the United States Minor Outlying Islands created?

ISO introduced the term "United States Minor Outlying Islands" in 1986. From 1974 until 1986, five of the islands (Baker Island,Howland Island,Jarvis Island,Palmyra Atoll,and Kingman Reef) were grouped under the term United States Miscellaneous Pacific Islands, with ISO 3166 code PU.

Are there seabirds in the Minor Outlying Islands?

Kingman Reef,Midway Atoll,Navassa Island: Their names have the power to inspire castaway fantasies,but the US Minor Outlying Islands are mostly visited by scientists and a squawking coterie of seabirds. In many cases,those seabirds are the reason the United States claimed the islands in the first place.

What is a um code for the Pacific Islands?

Except for Midway Atoll, the Pacific islands are surrounded by large exclusive economic zones and are within the bounds of the Pacific Remote IslandsMarine National Monument. They are collectively represented by the ISO 3166-1 alpha-2 code UM. The individual islands have ISO 3166-2 numerical codes.

Which Pacific Islands are inhabited by the US Navy?

As of 2008, only one of the islands, Wake Islandin the Pacific, is permanently inhabited by the US Navy and US Army. The other islands have had transient military activity or small colonies over the course of the last century. The Pacific islands are the following:

Which islands are claimed by the US under the Guano Islands Act?

Caroline Island, Kirimati, Flint Island, Malden Island, Starbuck Island, Vostok Island, Birnie Island, Gardner Island, Orona, McKean Island, Manra, Rawaki, Canton Island and Enderbury Island: claimed by the U.S. under the Guano Islands Act; claims ceded to Kiribati.
