Do solar PV installations need to be MCs certified?

Also, the Council of Mortgage Lenders has advised that, as a minimum to avoid the risk of a property being ineligible for a mortgage, both new and existing Solar PV installations must be MCS certified. All renewable energy products are examined by certification bodies against MCS manufacturing and testing standards.

What is a 3 day solar PV installation course?

Such a course is a requirement of the Minimum Technical Competency documentfor PV installers and is recognised by the MCS operators as evidence of suitable training. This 3 day course will enable candidates to select the most appropriate solar Photovoltaic system for a property to meet the client's needs and to commission and handover the system.

Are solar panels MCs accredited?

Unlike the Gas Safe Register, solar panel installers and suppliers are not required by law to be MCS accredited. Instead, the scheme rewards suppliers, installers, and products with a certificate if they meet a certain standard - reassuring customers that the product and service they're investing in will be of a good quality.

What if a solar product or installer isn't MCs accredited?

If a solar product or installer isn't MCS accredited,it's worth being a bit cautious. Although it's not a legal requirement for installers to be MCS accredited,consumers need to have a certificate for their solar panels if they are applying for financial funding through an incentive scheme,such as the Smart Export Guarantee (SEG).

Do PV tiles need MCs 005 certification?

This includes PV tiles and other products where PV elements are bonded to roof coverings such as standing seam roof sheets. Such products would also require certificationin accordance with MCS 005. Products relying solely on site applied sealants to provide a weathertight seal.

What does MCS certification mean for solar panels?
