Is Poland a member of the euro area?

Poland is not yet a member of the euro area. The zloty is not yet within the exchange rate mechanism (ERM II). The current euro to zloty foreign exchange reference rate can be consulted on the website of the European Central Bank (updated daily). Poland does not have a target date to adopt the euro, but aims to do so as soon as possible.

How is the euro adoption process regulated in Poland?

The euro adoption process in Poland is regulated by the Strategic Framework for National Euro Changeover Plan(adopted by the Council of Ministers in 2010) and the National Euro Changeover Plan (approved in 2011 by the Committee for European Affairs).
