

What will happen to Sael limited?

SAEL's commodities business, module assembly plant and other solar and biomass projects will be removed from SAEL Limited and injected into other unrestricted subsidiaries. All the unrestricted businesses and subsidiaries will not have any recourse to SAEL, but will have direct recourse to the new ultimate parent.

How much money will Sael Ltd get from US & European investors?

SAEL Ltd, which converts agricultural waste into energy, is close to finalising a fundraise of \$1 billion (about INR 8,300 crore) from US and European investors, said people aware of the matter. Ministry of New and Renewable Energy is working towards achieving 500 GW Non-fossil based electricity generation capacity by the end of this decade.

Is Sael a debt free company?

Warehousing business of SAEL is debt free. RICE HUSK /HULL: It constitutes the largest by-product of rice milling, as one-fifth of the paddy by weight is rice husk. Rice husk has a high calorific value of 3200-3300 k.cal/kg and is considered a good fuel for a variety of industrial uses.

Is Sael RG1 a good investment?
