Do solar panels invalidate NHBC?

Installing solar panels on new builds in the UK doesn'tautomatically invalidate the National House Building Council (NHBC) warranty, provided the installation is carried out by a fully certified installer and doesn't compromise the structural integrity of the building.

Do you need planning permission to install solar panels on your roof?

An increasing number of people are investing in solar energy. More and more homes are having solar panels, or solar tiles, installed on their roofs. Of course, with such installations, the topic of planning permission and building regulations often comes to the surface.

Can I install solar panels if I don't meet building regulations?

Are solar panels mandatory on new builds in the UK?

Solar panels aren't mandatoryon new builds in the UK. However, other parts of the world have implemented requirements - in the EU, for example, solar panels will be mandatory on all new residential buildings by 2030.

Can solar panels be installed without a planning system?

Changes to permitted development rights rules will mean more homeowners and businesses will be able to install solar panels on their roofs without going through the planning system. Currently those who have to go through the planning system are having to wait over eight weeks and face extra costs.
