What is the Puerto Rico solar access program?

The Solar Access Program is funded by the U.S. Department of Energy's Puerto Rico Energy Resilience Fund. For far too long,Puerto Ricans have lived with an unreliable and expensive electric system.

Who is installing solar panels in Puerto Rico?

Individuals and communities, including the Community Foundation of Puerto Rico, are installing solar panels and battery systems across the island. Javier Rivera is working on solar systems with 250 mostly rural, underserved communities.

Can solar power be used as a shelter in Puerto Rico?

A solar power system in its entirety can serve as a shelterin Puerto Rico, according to the person in charge. With abundant sunlight available, solar power has been booming in Puerto Rico since the hurricane. Across the island, individuals, communities, and businesses are installing solar panels and battery systems.

How much money does Puerto Rico have to pay for solar?

Up to \$190 millionis available to Puerto Rico's Housing Administration and a private company to pay for solar and battery installations in public housing common areas and subsidized, multifamily housing properties. Another \$175 million is available for certain healthcare and dialysis centers.

What is the Puerto Rico energy Resilience Fund?

This program, funded through the Puerto Rico Energy Resilience Fund, will provide solar panels and battery storage systems to low-income households in Puerto Rico with zero upfront costs, as well as education and support on how to use and maintain the systems.

Who can install photovoltaic systems in Puerto Rico?

Only certified installersmay install photovoltaic (PV) systems in Puerto Rico. In January 2010, additional regulations were passed requiring wind turbine installers to be certified as well in order to install wind systems.
